- fixed fees (e.g. tax returns, provisional tax returns, VAT/PAYE applications, company registrations, tax clearances etc.); **and**
- hourly fees (see below).

There are three types of hourly fees namely (1) administration/emails (2) calls and (3) Zoom meetings.

Each type of fee above can either be charged at the Standard Rate (basic replies & procedural replies) or at a higher Advanced Rate for advice-driven replies & more complicated calculations.

Hourly fees for South Africans are subject to VAT of 15%. Non-residents who live overseas and expats who plan to cease tax residency via SARS or are covered under Double Tax Agreements do not pay VAT.
